Authorization to Treat Minor

Summer Program Attendance Policies

- I understand that my child (in 2nd grade or higher) **must sign in** to program daily and my child (or his/her parent/guardian) **must sign out** of program daily.

Permissions to Evaluate Programs and Track Student Progress

- For the Level Up Summer 2023 Program, I give consent to San Diego Unified School District (SDUSD) to disclose to Level Up Summer 2023 Program Staff my child's confidential academic data (test scores, report cards, attendance, and other performance indices), and input my child's data into the database created for summer learning programs for the sole purpose of providing targeted support and academic instruction and assessing the academic effectiveness of the Level Up Summer 2023 Program. I also give permission for Level Up Summer 2023 program staff to monitor my student's progress and to request my child to voluntarily participate in evaluation surveys for the purpose of determining program effectiveness. I understand that consent to disclose information and evaluate programs is not a requirement to participate in the summer learning program and that I can withdraw this consent at any time by notifying the Level Up Summer 2023 and the SDUSD Summer Learning program office in writing.
